
**STRICT COMPLIANCE TO ISSUED GUIDELINES IN THE IMPLEMENTATION OF GENERAL COMMUNITY QUARANTINE IN THE PROVINCE OF NUEVA VIZCAYA**

To: Office of the Assistant Schools Division Superintendent  
 School Governance and Operations Division Chief

 Public Schools District Supervisors/District In-Charge  
 Public Elementary and Secondary School Heads  
 All others concerned

1. Upon the recommendation of the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases thru the issuance of IATF Resolution Nos. 107 and 107-A series 2021 dated 29 March 2021, the President has declared that the whole province be placed under General Community Quarantine from April 1-30, 2021. Given this, all DepEd personnel at all levels of governance both teaching and non-teaching shall comply with all the provisions and protocols stated in **Section 4 (page 13) of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of March 28, 2021.**
2. As stated in the same guideline, **“Any violation in the prohibitions stated therein shall constitute non-cooperation of the person or entities punishable under Section 9, par. (d) or (e), as the case may be, of Republic Act No. 11332, otherwise known as the Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act, and its Implementing Rules and Regulations”.**
