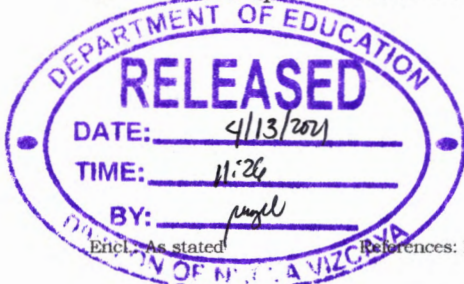
**DIVISION MEMORANDUM**

**CALL FOR PARTICIPANTS TO THE RESEARCH – WRITING WORKSHOP  
 FOR SCHOOL HEADS AND TEACHERS BATCHES 4, 5 AND 6**

1. Recognizing the importance of Research in improving the delivery of basic education services, DepED started to provide funding facility for research through the Basic Education Research Fund (BERF) and PLGUs' Provincial Special Education Fund (PSEF) for Educational Research.
2. Strengthening the implementation of the Research Management Guidelines as set in DepEd Order No. 16, s. 2017, the School Division Research Committee (SDRC) announces a conduct of Research Learning and Development for School Heads and Teachers tentatively scheduled on May 3-7, 2021 at SIL Bagabag Teachers' Camp, Bagabag, Nueva Vizcaya.
3. The Public Schools District Supervisor (PSDS) and District In – Charge, through their school heads, are requested to nominate/propose names of **participants with professional development needs along Research and do not have any comorbidities (diseases)**.
4. PSDS and DICs may instruct their proposed participants to log-in through this given link on or before April 16, 2021: <https://forms.gle/o7CNPZFwpm7WBLk8> . There will only be **3 slots per district**, i.e. 1 - Teacher, 1 – Master Teacher, 1 – School Head (TICs/HTs).
5. The Schools Division Research Committee (SDRC) and Professional Development Committee (PDC) will select the final list of participants and this will be issued on a separate memorandum.
6. Strict compliance and adherence to this memorandum is directed.
