**FOLLOW-UP SURVEY ON THE PERCEPTION OF TEACHERS AND  
OTHER SCHOOL PERSONNEL ON VACCINATION**

1. In preparation for the possible conduct of the face-to-face classes, and following the first round of survey happened last March 2021, the Department of Education (DepEd) will be conducting a **follow-up survey that seeks to gather perception of teachers and other school personnel on the ongoing vaccination program of the government.** This shall provide guidance to the Department in making informed decisions in relation to vaccination.

2. Further, the follow-up survey will provide an opportunity to further understand the situation on the ground in terms of perception of teachers and other school personnel on vaccination and in support to the BE – LCP Implementation.

3. The **follow-up survey (data gathering activity) will run from April 21, 2021 (8:00AM) to April 25, 2021 (5:00 PM) and shall be responded by all teaching and non-teaching/school personnel.**

4. Public School District Supervisors and District In-Charge are requested to help facilitate in disseminating the survey to their respective districts and to coordinate with their School Heads with regard to data collection and technical issues and concerns.

5. School heads and/or administrators from public and private are advised to disseminate the survey link to their respective teaching and non-teaching personnel and to ensure maximum participation in answering the survey.



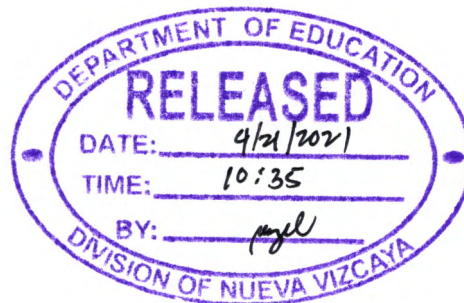


7. Participation in the survey is highly encouraged and must be emphasized in all forms of dissemination channels. Data Privacy shall be strictly observed.
