 FOR SCHOOL AND DISTRICT DRRM COORDINATORS**

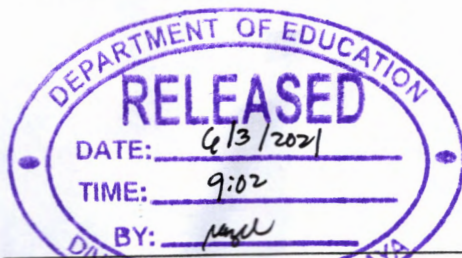
