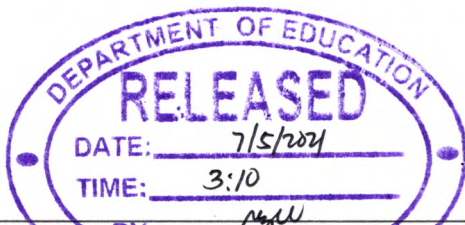
**CONDUCT OF MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT SERVICES
