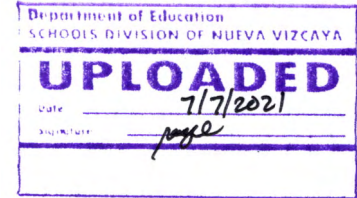

**CLINIQUING OF THE REGIONAL QUALIFIERS  
OF THE 2021 REGIONAL JOURNALYMPICS**

1. Pursuant to Republic Act No. 7079 known as the Campus Journalism Act of 1991 and relative to the conduct of Regional Online Journalympics 2021 to be hosted by the Division of Cauayan City on July 28-30, 2021, this office announces the Cliniquing of the Regional Qualifiers for Individual and Group categories. The activity will be a full virtual training via Google Meet and Discord platforms for 10 days to start on July 12 and ends on July 23, 2021.
2. The expected participants are the 2021 Regional Online Journalympics qualifiers which include the Top 2 in the individual category (elementary and secondary public and private pupils/students) and the champion of the group contest both in English and Filipino during the 2021 Division Online Journalympics. Participants are obliged to attend and actively participate in the required virtual platforms during the required sessions.
3. The coaches who will serve as trainers will be given 10-day service credits while compensatory timer-off credit will be given to school or division personnel who will be tapped to monitor the different activities during Saturdays and Sundays. Parent's permit must be secured from the participants.
4. Food of the technical working group (TWG) and facilitators, honoraria of the trainers/experts, supplies, internet allowance and other related expenses shall be charged to the Division Journalism Trust Fund subject to the usual accounting and auditing rules and regulations.
5. Attached herewith are the schedules, the list of trainers/facilitators and other staff of all the cliniquing sessions.

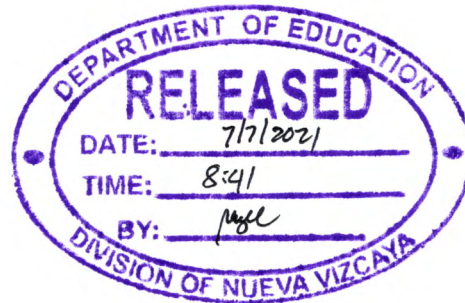
