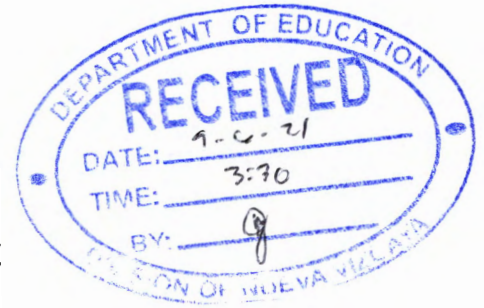

1. The unprecedented onset of this pandemic situation has placed significant pressure on the health care system managing disease and heightened the anxiety in seeking consults face-to-face among citizens. The School Governance and Operations Division- School Health Section (SGOD-SHS) conceptualized the Project H.E.L.L.O (**H**ea**l**th **E**ngagement with **L**earners & **e**mp**L**oyees via **O**nline) to provide a convenient and accessible primary care services for Nueva Vizcaya DepEd employees and learners from different districts especially clients with known comorbidities. It will allow clients to safely access health care without having to weigh-up the fear of COVID-19 infection.
2. This online consultation aims to create an additional platform for SDO Nueva Vizcaya School Health Section in providing health education in preventing disease complications that will help clients maintain an optimal health especially in this time of Pandemic.

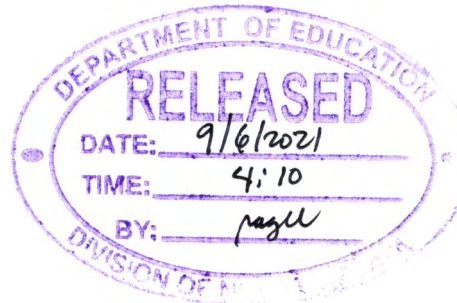
