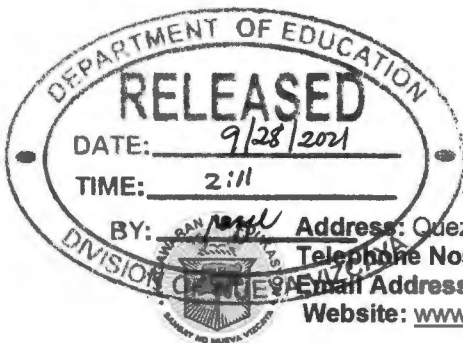


**VIRTUAL UPSKILLING OF CHILD PROTECTION COORDINATORS CUM
