**CAPABILITY BUILDING ON EFFECTIVE PARTNERSHIPS MANAGEMENT
IN THE NEW NORMAL FOR THE DISTRICT/SECONDARY PARTNERSHIP

1. Republic Act 8525 otherwise known as the Adopt-a-School Program Act of 1998 stipulates that private sector partners are invited to share or contribute their resources (time, services, financial/material donation, etc.) to public elementary and secondary schools.
2.  - d. share best practices and exploring ways of improving deliverables and sustainability of partners; and
 - e. refresh and enhance the use of DPDS in generating data of contribution or donation from partners.

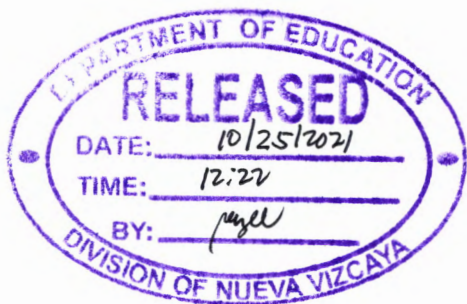
