**CULTURAL PRESENTATION GUIDELINES DURING THE 119TH
FOUNDING ANNIVERSARY OF SDO NUEVA VIZCAYA**

1. With reference to Division Memorandum No. 292, s. 2021 on the conduct of the 119th Founding Anniversary of SDO Nueva Vizcaya, the Committee on Cultural Presentation informs the schools/districts regarding the cultural presentation guidelines.
2. The cultural and video guidelines are hereby presented.

CULTURAL PRESENTATION GUIDELINES

- a. The district shall designate district cultural team coordinators. They shall be responsible in ensuring the quality of district performers.
- b. Dance presentation (folkdance, ethnic, dance fusion) could be the group's own interpretation of a folkloric dance from your area. Music presentation (solo, duet, quartet, group instrumental) could present any genre of folk music from their area. Participants should wear proper costumes and make up. Props are encouraged to be used for a better production.
- c. The district can use indigenous musical accompaniment (canned or live) for dances, while minus one or live accompaniment for vocal presentations.
- d. There shall be a maximum of eight (8) performers on the video, following strict IATF protocols. If all performers are fully vaccinated, they may or may not wear facemask. Face shields should be worn by the performers who are not yet fully vaccinated. Solo presentation may not wear face shield nor facemask.
- e. The presentation shall run from a minimum 2 minutes to a maximum of 4 minutes in the edited video including the introduction of the PSDS/DIC.

Video Guidelines

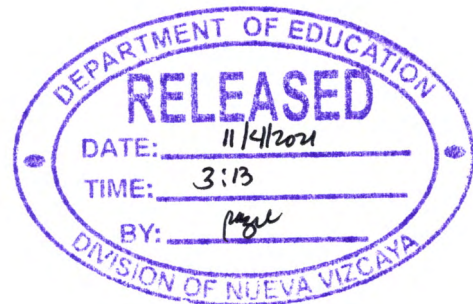
- a. Record your videos using smart phone, camera or camcorder.
 - b. All videos should be recorded in MP4 and landscape mode. The video should not have anyone else other than the performers.
 - c. Video should be taken just for the cultural presentation of the 119th SDO Anniversary. YouTube or FB video upload date should be after the commencement date of the presentation
 - d. At the beginning of each video, the PSDS/DIC of the district should announce the district, name of performer and school, brief introduction of the cultural showcase)” followed by “... participating in the 119 DepEd SDO Nueva Vizcaya Founding Anniversary”.
 - e. Video presentation must be received by November 19, 2021 at SDO CID Office attention: Macrino Raymundo, EPS-MAPEH or Roger Sebastian, EPS-Filipino.
