FOURTH (April 26 – June 11, 2021)	April 5, 2021




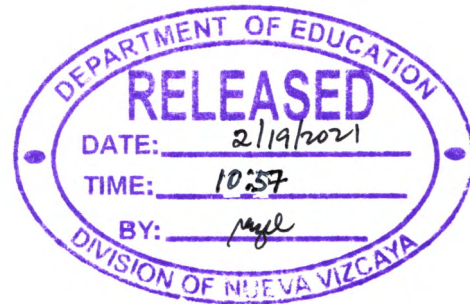
