1. Republic Act 8525, otherwise known as “Adopt-a-School Program Act of 1998” stipulates the engagement of diverse partners for the generation of donations or resources for schools. This is through the implementation of the Brigada Eskwela in schools and districts.
2. The ***Adopt-a-School Program Law*** stipulates that the state should provide quality and relevant education to the Filipino youth and to encourage private initiative to support public education. Towards this end, the State shall institute programs to encourage private companies and enterprises to help in the upgrading and modernization of public schools in the country.
3. Anent this, the schools and districts shall hold the simultaneous **Municipal 2022 Brigada Eskwela Kick-Off on August 8, 2022, 7:00 AM in their chosen venue/school.** This is through the support of the Local Government Units (LGUs) and other stakeholders.
4. The anchor Education Program Supervisors shall supervise the conduct of the 2022 Municipal Brigada Eskwela Kick Off in the schools/districts. Likewise, the nurses are requested to monitor the districts where they are assigned.
5. Partners and External Stakeholders are expected to participate in the kick off of the Brigada Eskwela maintenance works and other activities. Among the salient parts of the program include motorcade parade, preliminary activities, ceremonial signing of Pledge of Commitment of Stakeholders and Memorandum of Agreement/Understanding, turnover of donations and signing of Deed of Donations and Acceptance, among others.

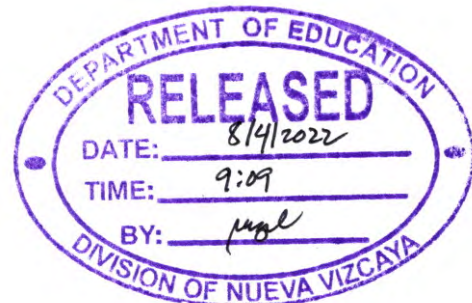
