FORMULATION OF THE BASIC EDUCATION DEVELOPMENT PLAN
(BEDP) for 2023 - 2028**

1. Pursuant to DepEd Order No. 24, s. 2022 known as "**Adoption of the Basic Education Development Plan 2030**", this office through the Performance Management and Planning Team informs the select participants in the conduct of the review of the DEDP and formulation of the Basic Education Development Plan (BEDP) for the years 2023 - 2028 on August 24-27, 2022 (day 0 will be August 24, 2022) with the venue to be announced later.
