REITERATION OF DEPED MEMO NO.016 S. 2021 RE: GUIDELINES ON THE NEW NATIONAL UNIFORM FOR TEACHING AND NON-TEACHING PERSONNEL

1. With the commencement of the SY 2022-2023, this Office reiterates the Guidelines on the New National uniform for the Teaching and Non-Teaching Personnel as indicated in DepED Memo 016, s.2021 emphasizing therein the prescribed sets of **uniform with respect to color/design for Male and Female Personnel** and the schedule for wearing the sets of uniform listed below:

Monday	Designs A for Male and Female
Tuesday	Designs B for Male and Female
Wednesday	Designs C for Male and Female
Thursday	Designs D for Male and Female
Friday	Any of the following as agreed by the school personnel for uniformity purposes: <ul style="list-style-type: none"> - Old Uniform (previous uniforms) - School uniform (collard shirt or any pair of established school uniform) - Decent Casual Wear
Non-teaching Personnel	
Monday & Wednesday	Design E for Male and Female
Tuesday & Thursday	Design F for Male and Female
Friday	Any of the following as agreed by the school personnel/ for SDO, thru the Functional Division Chief for uniformity purposes: <ul style="list-style-type: none"> - Old Uniform (previous uniforms) - School uniform (collared shirt or any pair of established school uniform) - Decent Casual Wear





2. The exemptions from wearing the above prescribed uniform (DM Item 9) remain but with the following reminders and considerations:
 - Use of tattered, skinny jeans and shirts or blouses with open & very low neckline & too high or above the knee skirt/dress are strongly discouraged.
 - Wear appropriate attire that is consistent with respectable dress code along the nature of work.
3. The school heads, PSDS/DICs and SDO Functional Division are advised to take appropriate monitoring mechanism to ensure compliance.
