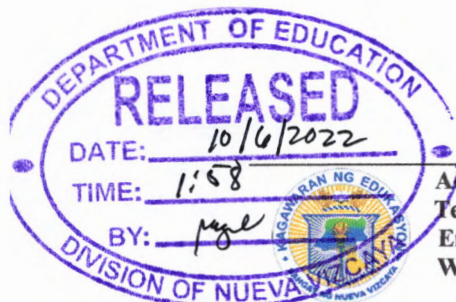
1. Pursuant to DepEd Memorandum No. 100 S-2016 and RA 9165 of the Dangerous Drug act of 2002 The National Drug Education Program (NDEP) is one of the five flagship programs of the Oplan Kalusugan sa Department of Education (OK sa DepEd) which aims to create awareness on the ill effects of abusing drugs and to develop among student's positive behavior and life skills to resist drugs, the Schools Governance and Operation Division, through the school health section, all schools are enjoined to conduct drug education activities in a school level observing zero disruption of classes.

2. The recommended activities are enjoined to highlight as follows:  
 a. Conduct of Drug symposium, essay, poster making and slogan contest and integration of NDEP concept in all subject areas.  
 b. Strengthening of student organization and Drug information drive campaign to parents.  
 c. Conduct of meeting with the nearby canteen operators on the issues of selling alcohols and cigarettes to learners.  
 d. Portray an advocacy slogan on dangerous drugs along hallway that is visible to students.

3. The School Health Section encourages all schools to sustain these recommended NDEP advocacy activities year round to ensure the safety, health and wellness of our learners the activities should be properly documented with write-up and pictorials. Submit hard and soft copy of reports in CD form on or before October 31, 2022 c/o Rudy S. Agustin, Division NDEP focal person.
