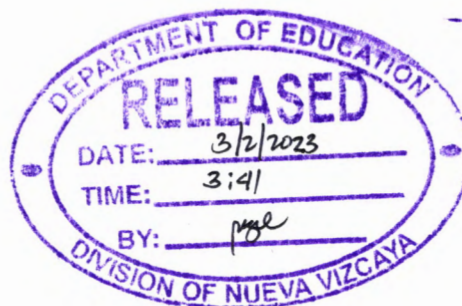

Search Miss Nueva Vizcaya Athletic Meet

Guidelines:

1. The competition is open to all enrolled female secondary learners of Nueva Vizcaya.
2. There shall only be one representative per municipality.
3. Contestants shall only prepare two attires namely, casual and sports attire.
Note that the only possible sports attire to be worn are the events played in the provincial meet.
4. Height requirement for contestants is at least 5'3".
5. Make-up artists are not allowed to be in the venue during the contest proper.
Only the teacher-coach or mother is allowed to assist the contestant.
6. There shall be exhibition of talent maximum of 3 minutes.
7. Wigs and artificial eyelashes are not allowed.
8. The delegation shall provide the needs of the contestant including their sash.
9. Awards shall be as follows:
Minor Awards
 - a. Miss Talent
 - b. Miss Casual Wear
 - c. Miss Sports Wear
 - d. Miss WitMajor Awards
 - a. 4th Runner Up
 - b. 3rd Runner Up
 - c. 2nd Runner Up
 - d. 1st Runner Up
 - e. Miss Nueva Vizcaya Athletic Meet
10. The criteria for judging are as follows:

a. CASUAL WEAR	20%
b. SPORTS WEAR	20%
c. TALENT	20%
d. WIT	20%
e. BEAUTY	20%
TOTAL	100%
