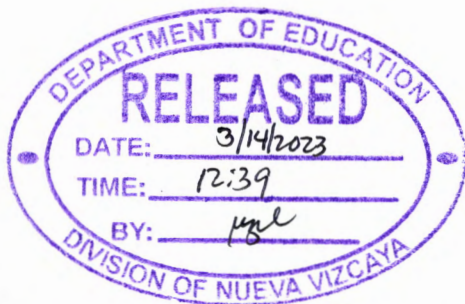



REGIONAL MEMORANDUM CIRCULAR

TO: ALL DILG PROVINCIAL DIRECTORS, CLUSTER HEADS, FIELD OFFICERS, AND OTHERS CONCERNED

SUBJECT: IMPLEMENTING GUIDELINES FOR THE 2023 PROJECT "MERAKI V2" - SCHOOLS AS BIDA ZONE: A MURAL COMPETITION

DATE: 27 FEBRUARY 2023

BACKGROUND

The Regional Inter-Agency Committee on Anti-Illegal Drugs (RICAD) Advocacy Cluster, as the authorized cluster to conceptualize and develop Information, Education and Communication materials for the promotion of anti-illegal drug activities, officially launch the Project MERAKI "Molding and Empowering Residents on Anti-Illegal Drug Activities through Knowledge Formation and Information Sharing" as their first project in April 2022.

In November 26, 2022, the **Buhay Ingatan, Droga'y Ayawan (BIDA) Program** was also simultaneously launched nationwide to amplify the call to support and inform the general public of the program. The BIDA Program is implemented in line with the priorities of the current administration to continue the campaign against illegal drugs "within the framework of law and with respect for human rights and with focus on rehabilitation and socio-economic development. It aims to reduce drug demand and supply by empowering and enjoining communities in the fight against illegal drugs.

Further, as enunciated in Memorandum Circular No. 2023-025 dated February 10, 2023 which sets the guidelines on implementing the BIDA Program, the DILG together with other partner agencies must continue to endeavor in raising the awareness of the people on the ill effects of dangerous drugs through Information, Education and Campaign (IEC). The Mural Competition is one concrete medium of IEC.

General Guidelines

1. Only one group per school may join the 2023 Project MERAKI - Schools as BIDA Zone: A Mural Competition
2. Each team must be composed of three (3) student-artist who are in Grades 9-12 of the current school year.
3. Online registration is **REQUIRED** and should be done on or before **March 8, 2023**. Online registration can be accessed through <https://tinyurl.com/57p4vtww>.

4. Upon online registration, participants must submit the following:
 - a) a scanned copy of their school IDs;
 - b) Certification signed by the Principal stating that the participants are officially enrolled in their respective schools for the current academic year (AY: 2022-2023).
 - c) Certification from the school through the Principal officially endorsing the applicants to the contest;
5. Incomplete or late registration is a ground for disqualification.
6. The artwork must be in accordance to the theme "**Kabataang BiBIDA Laban sa Droga**".
7. The number of entries per province is not limited but entries are subject to pre-judging before the contest proper. Pre-judging will be conducted by the DILG Regional Screening Committee.
8. Each team shall submit a mini version of their Mural design in a 1/2 size illustration board for the pre-judging together with a 3-5 sentences narrative explanation of their work. All entries must have a 1-3 word title. Entries may be submitted to DILG Provincial Offices to be forwarded immediately to DILG RO2 starting March 9, 2023. The deadline for submission of entries is on March 19, 2023.
9. Only the Top Ten (10) entries will be considered to proceed to the next round of the contest which is the mural painting.
10. The contest proper will be on March 27, 2023 in Cauayan City.
11. Winners will be announced during the BIDA Caravan on March 31, 2023.

Specific Contest Guidelines for the Top 10 Selected Entries:

1. Each team will be provided with One (1) panel board with white base color; 6-color set of latex paints; 3 pieces paint brush; water; and paint thinner.
2. All participating teams will make a mural through freehand drawing.
3. Eight (8) hours will be given to all teams to finish their mural designs.
4. Measuring and drawing tools are not allowed to be used for the mural designs.
5. Coaching by any person other than the officially registered contestants is not allowed. This is a valid ground for disqualification
6. Participants are expected to be at the venue one (1) hour before the contest for orientation and briefing.
7. All art pieces submitted will be a property of the DILG Region 02. However, the artists are not deprived of due recognition for the art works.

Adjudication Procedures

1. The decision of the judges is FINAL.

2. All art pieces are considered submitted once the Chair declares that the contest has finished.
3. The Panel of Judges will inspect all the entries submitted for grading. The three (3) highest scores will be given the corresponding awards.
4. Approaching any judge during the competition is not allowed.
5. Deductions/penalties are assessed at the sole discretion of the judges based on the rules set forth by the DILG RO2.
6. Clarifications or concerns should be directed and raised to the DILG RO2 prior to the competition.

Criteria for Judging

The criteria for judging will be as follows:


Creativity and Originality	30%
Quality of Art Piece <i>Accuracy of the drawing, control of the medium, quality of the colors and balance between colors and design.</i>	30%
Clarity of Theme <i>How well they represent the theme and whether the theme is understood by others.</i>	20%
Presentation <i>The presentation should be in accordance with the style of the art piece and the theme of the competition.</i>	20%
TOTAL	100%

Prizes

First Place	20,000.00 + Plaque of Recognition
Second Place	15,000.00 + Plaque of Recognition
Third Place	10,000.00 + Plaque of Recognition
7 Consolation Prizes	3,000.00 (each) + Certificate of Recognition

All Provincial Directors, Cluster Heads and Field Officers are enjoined to actively support the implementation of the 2023 Project MERAKE V2- Schools as BIDA Zone: A Mural Competition, and shall cause the immediate and widest dissemination of this memorandum.
