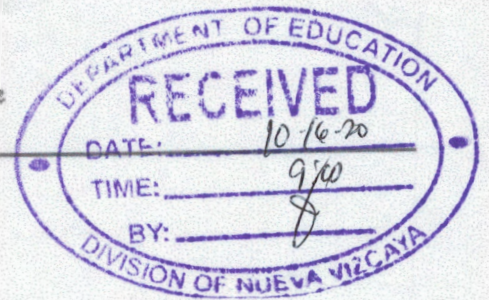

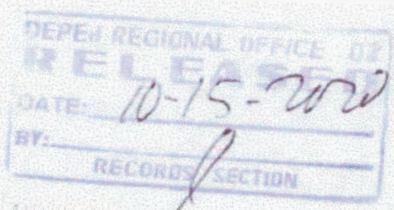
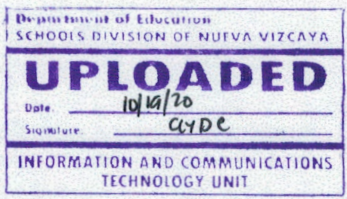
**Conduct of Virtual Career Guidance and School's Promotion of the University of Saint Louis of Tuguegarao City**

This Office informs the public that University of Saint Louis of Tuguegarao City is permitted to conduct virtual career guidance and school's promotion activities via Zoom in elementary and high schools in the City and in the Region on November, 2020.

In view of the aforementioned activity, this Office reiterates that the participation of public and private secondary schools is voluntary and shall be subject to the guidelines on the Conduct of Co-curricular and off-campus activities for public and private schools stipulated in D.O. 66, s. 2017 entitled Implementing Guidelines on the Conduct of Off-Campus Activities, and the no-collection policy as stated in Section 3 of Republic Act No. 5546, an Act Prohibiting Sale of Tickets and/or Collection of Contributions for whatever project or purpose from students and teachers of public and private schools, colleges and universities (Ganzon Law).

Strict compliance to National IATF policies and guidelines is highly desired to participating schools.

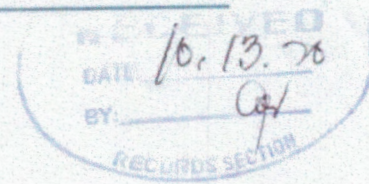

We are now targeting the Month of November for the launching of our virtual career guidance and school's promotion activities, in lieu of the face-to face and in-school campaign we used to do.


